#### FIRE PROTECTION AND CEMETERY MILLAGE RENEWAL

"Shall the previously expired voted increase in the tax limitations imposed under Article IX, Sec. 6 of the Michigan Constitution in Hope Township of 1 mill - .75 mill for Fire Protection and .25 mill for Cemetery (\$1.00 per \$1,000 of taxable value), reduced to 0.944 mills by the required millage rollbacks, be renewed at and increased up to the original voted 1 mill (\$1.00 of \$1,000 taxable value) and levied for 4 years, 2024 through 2027 inclusive, for the purpose of fire protection and cemetery maintenance, thereby raising an estimated \$180,961 in the first year the millage is levied?

"Shall the previously expired voted increase in the tax limitations imposed under Article IX, Sec. 6 of the Michigan Constitution in Hope Township of 1 mill (\$1.00 per \$1,000 of taxable value), reduced to 0.944 mills by the required millage rollbacks, be renewed at and increased up to the original voted 1 mill (\$1.00 of \$1,000 taxable value) and levied for 4 years, 2024 through 2027 inclusive, for the purpose of road repair, maintenance and operations expenses, raising an estimated \$180,961 in the first year the millage is levied?

#### MILLAGE RENEWAL PROPOSITION FOR FUNDING THE OPERATION OF OLDER CITIZEN SERVICES THROUGH BARRY COUNTY COMMISSION ON AGING

Shall Barry County renew the previously authorized millage of 0.4665 mill per year, (\$0.4665 per \$1,000 of taxable value) upon all taxable real and personal property in the County and shall said millage be increased by 0.0335 mill (\$0.0335 per \$1,000 of taxable value) to restore amounts reduced by the Headlee Amendment since the millage was first authorized in 2004, resulting in the levy of 0.5000 mill (\$0.50 per \$1,000 of taxable value), for a period of (5) years, 2025 through 2029, both inclusive, subject to reduction as provided by law?

The purpose of this levy is to provide funding for operation of Older Citizen Services through Barry County Commission on Aging.

It is estimated that a property located in Barry County with a taxable value of \$87,523 will pay \$43.76 in the first year of the levy.

If approved, it is estimated that the levy of 0.5000 mill would provide revenue of \$1,521,323 in the first calendar year of the levy, of which \$101,929 would result from the additional 0.0335 mill. The revenue from this millage will be disbursed to Barry County.

A small portion of the levy within a predefined area of the City of Hastings and Village of Middleville shall be disbursed to those respective entities DDA's and LDFA's. This amount comes from a predefined area within the City of Hastings and Village of Middleville only.
